Entry Requirements:

Each applicant must submit (2) photos representing the work to be displayed and sold. Each photo must be marked with the name of the vendor.

The Mackinaw Area Visitors Bureau is interested in providing an event with a well-balanced selection of arts & crafts.

All work **must** be the vendor's own and qualify as "fine arts or crafts". Items purchased for resale, used clothing and household items **will not** qualify. Only items listed on application will be permitted to be sold at events.

The Mackinaw Area Visitors Bureau reserves the right to ask for the removal of objectionable/misrepresented work at the show or to ask a vendor to leave without refund.

Fees:

Booth fees are \$75.00 per Art Show. All registrations 10 days or less prior to Art Show will be charged \$100.00. Please make your check or money order payable to: Mackinaw Area Visitors Bureau. Only complete applications are eligible for consideration.

Michigan Sales Tax:

Each artist is responsible for paying Michigan State Sales Tax. Please consult your accountant for further assistance.

Rules and Regulations:

Each vendor is responsible for bringing their own display. Spaces are on grass. This is an outdoor event; be prepared to deal with the elements. **Booth space is approximately 10 x 10. (No electricity available)**

Vendors must be present at their booths each day of the Show at all times. Space **cannot** be sublet, shared, or given to another vendor for any reason unless it is pre-approved by the Mackinaw Area Visitor Bureau.

Deadlines:

Applications will be taken up to two days before the event or until the event is full. Applicant will be sent a letter and notified of acceptance.

You will receive your photos back in your packet that you receive during check in. If your work is not juried into the Show, your check and photos will be returned.

Upon acceptance; your fee is **NON-REFUNDABLE.**

Cancellations for the event WILL NOT BE REFUNDED!

Setup and Fair Dates:

Welcome packets can be picked up at Conkling Heritage Park on Friday from 2 ~ 8pm and on Saturday morning from 7 ~ 9:30am. Unloading is from parking lot next to Park - Handcarts only to booths.

Booth Assignment:

Booth assignments will be assigned by the MAVB and will be in the packet you receive at check-in for Setup! **End Booths or Corner Booths are given on a lottery basis. A Vendor may request such space but is not guaranteed that they will receive it.**

On-site Security and Liability:

On-site and overnight security is provided. However, the Mackinaw Area Visitors Bureau and the sponsors are not responsible for fire, theft or damage to works or exhibits; injuries or personal items brought to the site.
