Entry Requirements

Each applicant must submit (2) photos representing the work to be displayed and sold. Each photo must be marked with the name of the vendor.

The Mackinaw Area Visitors Bureau is interested in providing an event with a well-balanced selection of arts and crafts.

All work must be the vendor's own and qualify as "fine arts or crafts" Items purchased for resale, used clothing, and household items will not qualify. Only items listed on application will be permitted to be sold at events.

The Mackinaw Area Visitors Bureau reserves the right to ask for the removal of objectionable or misrepresented work at the show or ask a vendor to leave without refund.

Rules and Regulations

Each vendor is responsible for bringing their own display. All spaces are on grass. Remember this is an outdoor event; be prepared to deal with the elements. Booth space is approximately 11x11. (No electricity available)

Vendors must be present at their booths each day of the Show at all times. And space cannot be sublet, shared, or given to another vendor for any reason unless pre-approved by the Mackinaw Area Visitor Bureau.

Booth Assignment

Booth assignments will be assigned by the MAVB and will be in the packet you receive at check-in for setup. **End Booths or Corner Booths are given on a lottery bases. A Vendor may request such space but is not guaranteed that they will receive it.**

Fees

The booth fee for each Art Show is \$75 if application is postmarked **before JUNE 1st. The fee will be \$100 for each application postmarked after that date.** Please make your check or money order out to the Mackinaw Area Visitors Bureau and only complete applications are eligible for consideration; incomplete applications will be returned.

Michigan Sales Tax

Each artist is responsible for paying Michigan State Sales Tax. Please consult your accountant for further assistance.

Deadlines

Applications will be taken up to two days before the event or until the event is full. Applicant will be notified of acceptance within a week from when application is received.

You will receive your photos back in your packet that you receive during check in. If your work is not juried into the Show, your check and photos will be returned.

Upon acceptance your fee is **NOT** refundable. **No Shows or cancellations for the event will not be refunded.**

On-site Security and Liability

On-site and overnight security is provided. However, the Mackinaw Area Visitors Bureau, and the sponsors are not responsible for fire, theft or damage to works or exhibits; injuries; or personal items brought to the site.

Setup and Fair Dates

Welcome packets can be picked up at the Visitors Bureau on Friday from 2-5pm and Conkling Heritage Park from 5-8pm Also on Saturday at the park from 7-9:30am. Unloading is from parking lot next to Park - Handcarts only to booths.
